

**ORDINANCE #21-08**

---

**AMENDING CHAPTER 2, ARTICLE IX OF THE VILLAGE CODE OF ORDINANCES  
REGARDING ELECTIONS, WARDS AND POLLING PLACE**

---

**THE VILLAGE BOARD OF THE VILLAGE OF JACKSON, WASHINGTON COUNTY, WISCONSIN**, does hereby ordain the following changes to the Village Code:

**WHEREAS**, pursuant to section 5.15, Wisconsin Statutes, the Village of Jackson shall be divided into election wards with boundaries based on Year 2020 U.S. Census data within 60 days after the receipt of a tentative county supervisory district plan for the County Board; and

**WHEREAS**, that said division must give consideration to the tentative plan submitted by the County Board,

**NOW THEREFORE**, the Village Board of the Village of Jackson, Washington County, Wisconsin does ordain as follows:

**SECTION I.** Amending Chapter 2-466 of the Municipal Code of the Village of Jackson, Wisconsin, creating election wards in the Village of Jackson under section 5.15 Wisconsin Statutes;

**Sec. 2-466. - Wards and polling place.**

A. WARDS (as referenced by the Village of Jackson Proposed Ward Plan dated September 27, 2021, attached to this ordinance.)

1. WARD 1: Census blocks in Tract 450103 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 1029, 1030, 1031, 1032, 1033, 1034. Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 1014, 1015, 1016, 1017.
2. WARD 2: Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 1005, 1006, 1007, 1008, 1009, 1010, 1011, 1012, 1013, 1031, 1034, 1063, 1064, 1065, 1066.
3. WARD 3: Census blocks in Tract 450103 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2005, 2006, 2007, 2009, 2019, 2020, 2021, 2022, 2023, 2024, 2025, 2026, 2027, 2028.
4. WARD 4: Census blocks in Tract 450103 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 1020 (Part), 1021, 2000, 2001, 2002, 2015, 2016, 3002, 3003 (Part), 3007, 3008, 3009, 3010, 3011, 3012, 3013, 3014, 3015, 4010 (Part), 4011.

5. WARD 5: Census blocks in Tract 450103 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2012, 2013, 2014, 2017, 2018, 3019, 3020, 3021, 3022.
6. WARD 6: Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 3001, 3002.
7. WARD 7: Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2003, 2004, 2007, 2008.
8. WARD 8: Census blocks in Tract 450103 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 3000, 3004, 3005, 3006, 3016, 3017, 3018, 3023, 3024 (Part), 4019.
9. WARD 9: Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2000, 2002, 2005, 2006. Census blocks in Tract 450108 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2001, 2002, 2003, 2004, 2005, 2006, 2015, 2016, 2017, 2018.
10. WARD 10: Census blocks in Tract 450107 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 1000, 1001, 1002, 1003, 1004, 3003, 3004, 3005, 3006, 3007.
11. WARD 11: Census blocks in Tract 450108 that are within the Village limits of the Village of Jackson in Washington County, Wisconsin. Blocks 2007 (Part), 2008 (Part), 2009 (Part), 2010 (Part), 2011 (Part), 2013 (Part), 2014 (Part), 2019 (Part), 2020.

B. POLLING PLACE The polling place for all wards shall be the Village of Jackson Municipal Complex, N167W19851 Main Street in the Village of Jackson.

**SECTION II.** This Ordinance shall, upon passage and posting, become effective for elections after December 31, 2021.


